Please consider allowing PRCF to administer your legacy gift to an existing fund or a new fund.

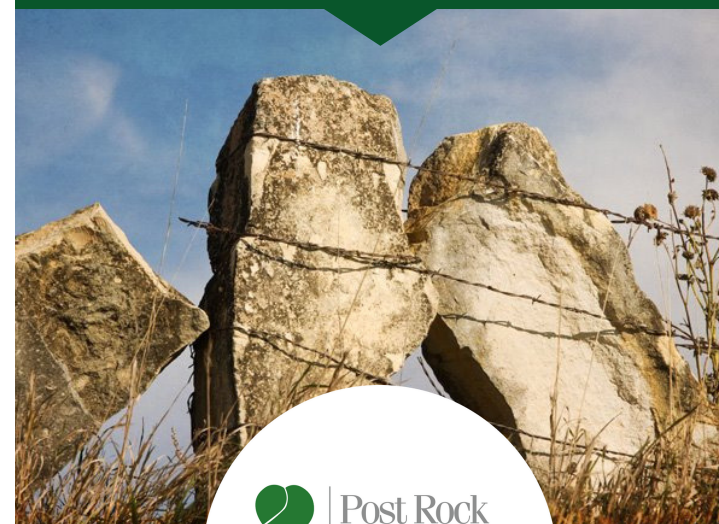
